

SimplexGrinnell's Disaster Recovery plan is confidential and, thus, is not released to third parties. SimplexGrinnell has established a recovery plan to ensure that its business systems are recovered in a timely manner in the event of a disaster. We work with a third party vendor experienced in providing disaster recovery service. As part of this plan, SimplexGrinnell conducts periodic Disaster Tests to ensure that its plan is effective and to measure the efficiency of plan improvements. In addition, SimplexGrinnell's monitoring center operates a concurrent backup system in another location. This system mirrors SimplexGrinnell's central station facility. If an unforeseen event were to affect the central station, all calls would be automatically redirected to the backup facility to provide customers with seamless monitoring of their systems.

#### Supplier Diversity:

Tyco's Supplier Diversity Program is committed to contributing to a sustainable competitive advantage in the markets we serve by integrating minority, woman, veteran owned, disable-owned and HUBZone businesses into our strategic sourcing process and providing these businesses with a solid foundation for building capacity to capture significant growth opportunities. SimplexGrinnell, a major business unit of Tyco, shares in this commitment.

Supplier diversity has become a key business strategy for progressive multi-national corporations. As a customer driven organization, we are focused on fully understanding and exceeding our customers' needs, wants, and preferences and providing greater value to our customers. To achieve this, we have worked to build our organization and supply base to reflect the demographics and virtues of our stakeholders and customers.

In 2005, Tyco International's spend with Minority and Woman-Owned Enterprise (MWBE) suppliers was \$98M, or 2% of U.S. purchases. In 2009, our latest reporting period, Tyco increased its spend with MWBEs from 5% to 5.5% of U.S purchases. SimplexGrinnell purchased 9% of its goods and services from MWBEs in FY09.

In FY10, Tyco International's spend with Minority and Woman-Owned Enterprise (MWBE) suppliers was 6.6% of U.S. purchases, representing an increase of 1.1% from the previous year. SimplexGrinnell purchased 15.2% of its goods and services from MWBEs in FY10, a significant increase from 8.9% in FY09.
